**MV Purchasing, LLC pricing statement:**

Subject to change without notice and to the terms and conditions of its applicable division orders and other contracts, MV Purchasing, LLC (MVP) or its affiliates will pay the above applicable prices per barrel for virgin, settled, merchantable crude oil and condensate purchased by it from the areas designated. All prices may be subject to deductions for transportation, quality, and other charges where applicable. All prices will be effective at 7 a.m. (Central Time) on date of change.

Prices posted are for crude petroleum with an American Petroleum Institute (API) gravity equal to 40 degrees. Measurement is based upon computation of volume by the use of 100% tank tables, or by the use of mutually acceptable measuring equipment, corrected for temperature to 60 degrees Fahrenheit per API standards with full deduction for basic sediment and water.

MVP reserves the right, without prejudice, to reject and return to Seller any quantities of crude oil and/or condensate which are found (even after delivery to MVP) to be contaminated by chemicals foreign to virgin crude and/or condensate.

In the event that federal regulations or rulings require adjustments to MVP prices, MVP reserves the right to amend these postings and recover any excess payments by withholding or invoicing amounts not allowed under subsequent or retroactive limitations.
